Nkihagera yatangiye guhira umugore wanjye, avuga ko atazagira amahoro akiliho; nkagira ngo n'ibikino, none akwo yabivuze koko, ndabona alibyo biba. Bukeye le 26/11/76? NIBWO BAMUFUNGIYE MULI CACHOT YA GANTON I NYAMIRAMBO, ni nabwo yanditse iyo baruwa mboherereje atakamba, kandi ali mu kagozi.

Mbere aho kuli le 15/11/76 yali yandikiye bourgmestre, ansebereza umugore, ngo niwe ucumbikiye indaya n'amabandi, nkaho urugo rwanjye atalinjye urutegeka. Iyo baruwa sinshoboye kuyibonera copie iba mu Rukiko rwa Kanto i Nyamirambo, nyanara kandi nta gisubizo nali nabomera icyo kibazo kandi giteye agahinda; indi copie ili muli PARQUET y'i Kigali; nayo byahareye aho.

Le 18.11.76, nabwo yohereje indi barwa isa niyo naze kuvuga, ngiyo ndayiboherereje. Ubona ko icyo agamije kвали nkumbuba amahoro no kunsenyera gusa. Amahirwe nagize icyo gihe, ni uko Komine yakoze anekte, igasanga Sefara hali akagambane afite kagamije kungilira nabi, yuko bavumbuye ko yakoze amayere mafi asinyisha ba selire kuli iyo barwa mboherereje, avuga ngo ni amategeko ya Ministeri del'interieur

Le 12/5/77, nabonye indi barwa incnyesha ko agiye kunsenyera, ngayo nayo ndayiboherereje. Rwose uretse gukabya uwo mugabo angeze kure uretse aha Nygasani gusa.

Le 30/6/77, abonye ko abyo yankoreye byose nabismbutse, ajya guhuruza directeur w'ubuhinzi n'ubworoz, bansenyeru ku manwa izuba liva, ahantu nubatse muli 1975, basenya inzu zo ku ruhande zose zifite 23 M/5, hamwe n'urupango nali nubakishije anabuye n'amatafali lugirango binfashe kwilinda abanyoni, ilyo sehya limpombya amafuranga 231.000, kandi linatuha kugeza ubu ntashobora kugira aho nituma.

Ubwo niho nabonye koko ko "SEFARA afite umugambi wo kunsenyera uko yali yarabyibwiriye umugore wanjye. Nibwo nandikiye Ministre w'ubuhinzi, n'ubworoz, antegeta kuba itegereje. Nymara kandi SEFARA Uwo we yaliyubakiraga, kuko duturanye, na nubu kandi we arubaka.

bamugejeje i Nyamirambo, bamubwira ko ataha bakazongera kumutumaho

Le 19/5/79 saa kumi, wa mu gendarme  
agaruka iwanjye nanone atwara madame wanjye, amugejeje kuli Brigade  
ahasanga caporal BIZIMA ahita amukubita FIR A BETON, amukubita  
umutego amutura hasi, yiyambura umukandara wa gisilikare, maze arahondagura  
mbese si ugukubita rwose aramubaga, nkaho uwo mugore wanjye yaba yishe  
umuntu. Ubwo kandi yakubitwaga atyo atazi icyo azira, ndetse na nuba  
nta cyaha bamushinje, urutse kumukubita gusa. Bamaze kumugira inonge  
bamujugunya mu modoka yali yabatiwe aho, bamujyana kya Muganga,  
bamugejeje mw'ibagiro bamuta aho. Nyuma nibwo caporal Bizimana yaje




